### Space Availability

All spots on this trip will be filled on a **first come - first served** basis per postmark, and are secured ONLY with payment of the initial deposit of \$800 per person and 2019/2020 AE Ski Club membership when enrollment opens in July/August. In the past these trips have sold out very quickly, so don't delay there are only **42 spots** available.

### Payment Policy

You can pay by check or money order payable to the AE Ski Club. Sorry, we don't accept credit cards. Checks returned as unpaid by the bank will be assessed a \$30.00 fee per occurrence. The following payment plan has been set up:

- Deposit of **\$800** is due at sign up; membership enrollment will be required in July/August.
- Second payment of **\$800** is due October 1, 2019.
- Balance / Final payment of **\$795** due December 1, 2019.

### Cancellation Policy

**If you need to cancel, you must provide written notice to the trip leader.** The following charges will apply (per person) based upon the date of receipt of written cancellation notice. Every effort will be made to substitute from the waiting list (if there is one) for any cancellations. Cancellation fees will be automatically deducted from any applicable refund. Any questions about the cancellation policy should be directed to your trip leaders. In all cases, cancelling party is subject to re-ticketing fee assessed by airline.
