**SNOWBIRD**, Utah is in the heart of the Wasatch-Cache National Forest in Little Cottonwood Canyon.

**SNOWBIRD** offers a wide variety of terrain and is one of the most snow-sure destinations in the USA. There are 45 designated runs and 3,100 continuously skiable vertical feet. In addition, the terrain includes long rolling runs to wide bowls and narrow chutes.

**Snowfall:** Snowbird averages approximately 500 inches of low-density, "dry" Utah powder annually. Thanks to ideal geography and a phenomenon called Lake Effect, Little Cottonwood Canyon powder is known worldwide.

**ALTA Ski Area** is 1 mile up the road from Snowbird. It is accessible via local shuttle. ALSO, a connection gate sits at the saddle separating Alta's Albion Basin and Snowbird's Mineral Basin. This gate is accessible with the Alta-Snowbird ticket, which enables skiers to access both resorts' terrain.

**ALTA Ski Area is for skiers and restricts the use of equipment other than skis** for anyone who wants to ride the lifts, ski the mountain or play around the base areas.

**ALTA Ski Area** is world renowned for its steep and deep powder skiing—averaging 547" of snow each winter. But did you know that 45% of the terrain is suitable for beginner and intermediate skiers?

**Hotel Accommodations:** THE CLIFF LODGE---a deluxe full-service ski-in ski-out hotel with a wide range of amenities including a rooftop spa, Jacuzzi, health club, two outdoor heated pools, four distinctive restaurants, lounges, laundry facilities, and retail shops. Originally built in 1973 by the Gaylord family, the Cliff Lodge has since doubled in size and increased dramatically in amenities. Offering four restaurants, two lounges, two swimming pools, four hot tubs and Snowbird's only ski-out, ski-in accessibility. The hotel guest pool and three hot tubs are located outdoors on Level 3 and are heated year-round. The Cliff Lodge also offers a ski shop with full rental facilities, a ticket window, Mountain School office, concierge and entertainment throughout the winter. Included in each Cliff Lodge room: hairdryer, coffee maker, small refrigerator, iron and ironing board.

## **Space Availability**

All spots on this trip will be filled on a **first come – first served basis** and are secured ONLY with initial deposit of **\$800** per person. Participants must also become a paid member of the AE Ski Club for the 2021/2022 season once membership enrollment opens up in the fall. In the past these trips have sold out very quickly, so don't delay. A waiting list will be formed as necessary. Note, this trip is sold as a package, therefore, deviations are not available.

## **Payment**

You can pay by check or money order payable to the AE Ski Club. Sorry, we don't accept credit cards. Checks returned as unpaid by the bank will be assessed a \$20.00 fee per occurrence. Payment plan as follows:

- Deposit of **\$800** (Must sign up as a member for **2021/2022** when enrollment opens in the fall)
- 2<sup>nd</sup> payment of **\$800 due October 1, 2021.**
- Final payment of **\$725 due December 1, 2021. (\$555 if not skiing Alta)**

## **Cancellation Policy**

**If you need to cancel, you must provide written notice to one of the trip leaders.** The following charges will apply (per person) based upon the date of receipt of written cancellation notice:

On or before November 23, 2021	\$295 per person
On or before December 23, 2021	\$595 per person
