## WHITEFISH, Montana

Whitefish Mountain Resort is located in the Rocky Mountains of northwest Montana, near Glacier National Park and just 7 miles from the beautiful town of Whitefish.

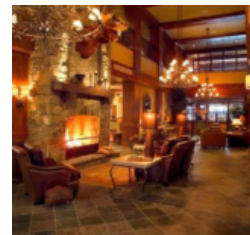
The Resort boasts an average of 300" of Rocky Mountain snow, over 3,000 acres of terrain, and blissfully uncrowded slopes served by 11 lifts, including 3 high speed quads. With fewer skiers per acre than any other major ski resort, Whitefish Mountain Resort has amazingly short lift lines.

No need to worry about altitude sickness at Whitefish – the summit is just under 7,000 feet and the village base is at 4,464 feet. With 93 marked runs, vast bowls and awesome tree skiing, their beginner runs (20%) are on the front and back side of the mountain, as well as their intertwined intermediate (50%) and advanced/expert runs (30%).

Winter activities include skiing and snowboarding, snowmobiling, cat skiing, guided tours of Glacier National Park and Moonlight Dine and Ski evenings. So even if you choose to take a day off from skiing, there is plenty of adventure to be found nearby.

## HOTEL ACCOMMODATIONS

Nestled between majestic mountains and pristine waters lies Montana's only Four Diamond-rated resort — **The Lodge at Whitefish Lake**. The Lodge is truly a special place; situated between Whitefish Lake and the 28-acre Viking Creek Wetland Preserve, with breathtaking scenery at every turn and no shortage of Montana adventures to experience. Inspired by the grand lodges of the past, The Lodge offers genuine western hospitality sure to create cherished moments and lasting memories. The Viking Lodge has its own hot tub and pool, sitting area, fireplace, flat screen HDTV, 1200 sq. ft. fitness center, ski storage, and also provides a complimentary shuttle to the mountain and to town.

## **COVID-19 Note**

In the event that restrictions imposed by the COVID-19 virus or other pandemic prevent travel, the trip will be postponed until 2023. ## **Trip Insurance**

Trip insurance is highly recommended! Through our tour provider, we are able to offer you 2 insurance options customized for this trip. **You must sign up on your own through the link provided below.** The cost of the trip insurance is not refundable.

The first option is for the standard Travel Insured **Worldwide Trip Protector Lite Policy** (note: pandemic not covered). The second option is the Travel Insured **Worldwide Trip Protector Policy** with CFAR (Cancel for Any Reason) offered as an add-on. **You must sign up for the Travel Insured Worldwide Trip Protector and select CFAR (Cancel for Any Reason) as an add-on option within 14 days of the date your initial deposit for your trip.**

## **Space Availability**

All spots on this trip will be filled on a **first come – first served basis** and are secured ONLY with initial deposit of **\$800** per person. Participants must also become a paid member of the AE Ski Club for the 2021/2022 season once membership enrollment opens up in the fall. In the past these trips have sold out very quickly, so don't delay! A waiting list will be created as necessary. Note, this trip is sold as a package and deviations are not available.

## **Payment**

You can pay by check or money order payable to the AE Ski Club. Sorry, we don't accept credit cards.

Checks returned as unpaid by the bank will be assessed a \$30.00 fee per occurrence.

Payment plan as follows:

- **Deposit of \$800 upon registration**
- **Final payment of \$836 (5-Day Lift Pass) or \$891 (6-Day Lift Pass) due by November 1, 2021**
- **Membership fees for 2021/2022 (Must sign up as a member for 2021/2022 when enrollment opens in the fall)**

## **Cancellation Policy**

**If you need to cancel, you must provide written notice to one of the trip leaders.** The following charges will apply (per person) based upon the date of receipt of written cancellation notice:
