Steamboat Skiing:

Steamboat is a complete mountain range: Mount Werner, Sunshine Peak, Storm Peak, Thunderhead Peak, Pioneer Ridge, and Christie Peak. With 2,939 acres of permitted terrain, it offers a diversity of trails for all levels of ability! The glade areas of Sunshine and Storm Peaks are Steamboat's particular claim to fame, with legendary powder in the trees for the most die-hard Steamboat powder hound, with 17 lifts on the mountain with 170 named trails and an average snowfall of 314". 14% beginner trails, 42% intermediate and 44% advanced runs, with the longest run being 3 miles long. Steamboat is located in northwest Colorado, about 160 miles northwest of Denver.

Other than skiing, there is a Hot Springs 7 miles away from the Ptarmigan Inn. You can also enjoy the outdoor skating rink, or take a snowmobile tour through the continental divide/Routt National Forest –sunset tours available also!

Or take a tour of the Tread of Pioneers Museum - a "must do" for visitors and locals alike offering year-round fun and exploration of Steamboat's distinct Western heritage. Discover the people and events that shaped this once wild western frontier outpost into a beloved Rocky Mountain destination resort town and find out why Steamboat Springs is home to more Olympic athletes than any other town in North America.
