SNOWBIRD offers a wide variety of terrain and is one of the most snow-sure destinations in the USA. There are 45 designated runs and 3,100 continuously skiable vertical feet.

Snowfall: Snowbird averages approximately 500 inches of low-density, "dry" Utah powder annually. Thanks to ideal geography and a phenomenon called Lake Effect, Little Cottonwood Canyon powder is known worldwide.



ALTA Ski Area is 1 mile up the road from Snowbird. It is accessible via local shuttle. Also, a connection gate sits at the saddle separating Alta's Albion Basin and Snowbird's Mineral Basin. This gate is accessible with the Alta-Snowbird ticket, which enables skiers to access both resorts' terrain.

ALTA Ski Area is world renowned for its steep and deep powder skiing—averaging 547" of snow each winter. But did you know that 45% of the terrain is suitable for beginner and intermediate skiers?

ALTA Ski Area is for skiers.

Snowboarding is not permitted at ALTA Ski Area.

Cancellation Policy

In the event of a trip cancellation, we will make every attempt to provide refunds OR defer the trip to a later date. Each trip will be handled on a per trip basis, not an individual participant basis. Some restrictions and penalties apply to your vacation investment. If you cancel your reservations, YOUR RIGHT TO A REFUND IS LIMITED, as set forth in the following schedule. We strongly recommend each participant **purchase trip insurance** that allows for cancellation for any reason to best protect themselves.

If you need to cancel, you must provide written notice to the trip leader. If participants choose to cancel, the following charges will apply (per person) based upon the date of receipt of written cancellation notice:

TRIP CANCELLATION/INTERRUPTION INSURANCE:

Group agrees to be expressly and solely responsible for any damage or injury caused or suffered by any Group member, or any person associated, affiliated, or related to any Group member.
- C. Waiver.** I agree that neither AE Ski Club nor ATI nor its affiliates, nor its or their volunteers, employees or agents, shall be liable for any damage, loss (including personal injury, death and property loss), inconvenience or expense occasioned by any act or omission of any supplier providing services, or of any other person, or by any change in itinerary, unless caused by the negligence of AE Ski Club or its affiliates or their employees or agents in the contractual duty. No person other than a representative of AE Ski Club authorized by a document in writing is permitted to vary, add, or waive any term or condition in this Agreement, including any term or condition set forth in the preceding provisions.
- D.
