**Space Availability**

All spots on this trip will be filled on a **first come – first served basis** and are secured ONLY with payment of the initial deposit of \$250 per person. **All trip participants must be paid members of the club for the 2023/2024 season prior to sign up and must purchase a membership for the 2024/2025 season.** In the past these trips have sold out very quickly, so do not delay. A waiting list will be formed, if necessary.

**Payment Policy**

The initial non-refundable deposit is payable only on the website via PayPal, Venmo or credit card. You can make the second and final payments by check or money order payable to the "AE Ski Club". We do not accept credit cards for payments other than the initial deposit. Checks returned as unpaid by the bank will be assessed a \$35.00 fee per occurrence. **Cancellation Policy**

In the event of a trip cancellation, every attempt will be made to provide refunds OR defer the trip to a later date. Trip cancellations may occur because of COVID-related restrictions or other issues. Each trip will be handled on a per trip basis, not an individual participant basis. We strongly recommend each participant purchase trip insurance that allows for Cancellation For Any Reason (CFAR) to best protect themselves.

**If you need to cancel, you must provide written notice to the trip leaders.** Charges will apply (per person) based upon the date of receipt of written cancellation notice as indicated below:

Group agrees to be expressly and solely responsible for any damage or injury caused or suffered by any Group member, or any person associated, affiliated, or related to any Group member.
