Providing ski-in, ski-out access to Jackson Hole Mountain Resort, this boutique hotel, just 50 yards from the Jackson Hole Tram, features an outdoor pool and hot tub. Free Wi-Fi is included. Guest rooms at The Alpenhof feature hand-crafted Bavarian furniture and private balconies. Each guest room includes a satellite TV, a work desk, a sitting area and ironing facilities. Guests can enjoy casual dining at the Alpenhof Bar & Bistro, which features microbrews and a wine list, or dine on Alpine-inspired cuisine at Alpenrose restaurant. Guests of The Alpenhof can enjoy a relaxing all organic massage or body treatment. Ski storage is provided at the hotel. ## The Skiing

Jackson Hole Mountain Resort has consistently been voted the best ski and snowboard destination in the U.S. While Jackson Hole Mountain Resort offers tons of expert terrain, about 50 percent of the terrain is dedicated to intermediate and beginner slopes. Access to intermediate and beginner terrain is easy, right from the base. With a variety of terrain available, there will be new trails for everyone in your group. Known to locals as “the box,” “the red heli,” or “big red,” the Aerial Tram at Jackson Hole Mountain Resort can carry 100 people to the top of Rendezvous Peak (10,450 feet) in just 12 minutes! The tram makes the mountain’s expert and backcountry terrain accessible to more experienced skiers. Just before docking at the top of the mountain, the tram passes directly above Corbet’s Couloir, for a view of one of the toughest ski runs at Jackson Hole (and maybe even in the world!). Jackson Hole accepts the FULL IKON Pass.

### Space Availability

All spots on this trip will be filled on a **first come – first served basis** and are secured **ONLY** with payment of the online deposit immediately followed by the first payment of \$914 per person (\$1,314 w/ 5-day lift pass).

All spots on this trip will be filled on a First Come – First Served Basis.

- Existing Active Members 2023/2024 – You can sign up for the trip first, but you must become a paid active member of the club for the 2024/2025 season once membership enrollment opens up in July.
  - New Members – You must become a paid active member of the club for the 2023/2024 season before you sign up for this trip. Membership for 2024/2025 season will automatically be renewed in July at no cost.
- In the past these trips have sold out very quickly, so don't delay! If the trip sells out, we will start a waiting list.

### Payment Policy

You can pay by check or money order payable to the AE Ski Club. Sorry, we don't accept credit cards. Checks returned as unpaid by the bank will be assessed a \$30.00 fee per occurrence. The following payment plan is required:

- Paypal/Venmo deposit on signup \$250
- Payment of **\$914** due upon registration (**\$1,314** w/ 5-day lift pass) July 15, 2024
- Final payment of **\$1164** (**\$1564** w/ 5-day lift pass) due November 1, 2024
- Membership fees for **2024/2025** (Existing members enrollment opens July 2025)

### Cancellation Policy

In the event of a trip cancellation, we will make every attempt to provide refunds OR defer the trip to a later date. Each trip will be handled on a per trip basis, not an individual participant basis. Some restrictions and penalties apply to your vacation investment. If you cancel your reservations, **YOUR RIGHT TO A REFUND IS LIMITED**, as set forth in the following schedule. We strongly recommend each participant **purchase trip insurance** that allows for cancellation for any reason to best protect themselves.

**If you need to cancel, you must provide written notice to the trip leader.** If participants choose to cancel, the following charges will apply (per person) based upon the date of receipt of written cancellation notice:

Group agrees to be expressly and solely responsible for any damage or injury caused or suffered by any Group member, or any person associated, affiliated, or related to any Group member.

**C.
